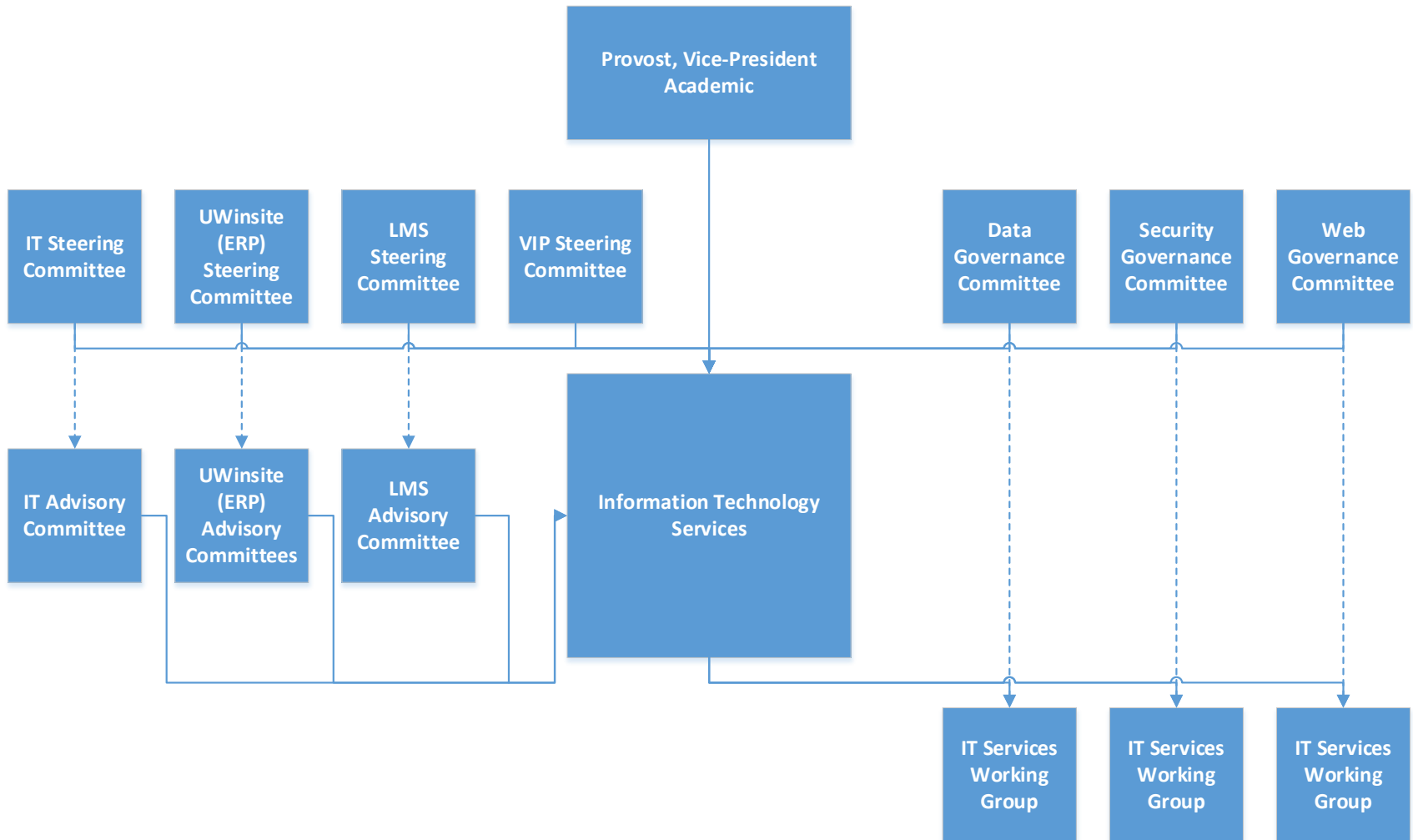

IT Steering Committee – Terms of Reference

Mandate

- The Information Technology Steering Committee will develop, update, communicate and oversee the implementation of the strategic vision and objectives for the University's information and communications technology

Responsibilities

- Develop, review, update, communicate and oversee the implementation of Information Technology Strategic Plan
- Review, prioritize and recommend University's IT investments with a view to maximizing value from IT investments
- Establish and follow processes for receiving, reviewing and approving campus-wide information technology project requests on an annual basis
- Monitor information technology projects implementation through appropriate project status reports
- Discuss, endorse and/or approve policies, procedures, practices and guidelines with respect to IT and facilitate compliance
- Balance the short-term needs of individual departments and faculties with the long-term needs of the whole institution
- Identification and mitigation of organizational risk as it pertains to Information Technology

Mandate

- The Information Technology Advisory Committee will facilitate a broad based stakeholder engagement to review, and recommend efficient and effective use of Information Technology tools and solutions, and promote their adoption at the University of Windsor

Responsibilities

IT Governance Framework – Review and Refinement

- As part of the implementation of the IT Strategic Plan, IT Services has worked collaboratively with University leadership and other key stakeholders to complete an overall review of all IT related governance frameworks to ensure that they are:
 - Generally aligned and support strategic priorities of the University and IT Services
 - Achieving identified mandates
 - Maintaining appropriate structures and representative memberships
 - Delivering value to the campus
- IT Services has also completed a process to review and revise its existing Project Management (PMO) process in order to ensure:
 - Clarity and transparency on the project intake process for the Department
 - An appropriate balance between the need for technologies and services against available resources
 - Prioritization amongst competing requests
 - Principles of stewardship and sustainability are adequately addressed as part of all project related decisions



IT Governance Framework – Sustainment

- IT Services will regularly review and assess the overall effectiveness of the IT Governance Framework and supporting processes in order to ensure that identified objectives are achieved both effectively and efficiently
- Where required, IT Services will use appropriate channels and corresponding due process to make further refinements to the overall IT Governance Framework in order to maintain effectiveness and achieve objectives
